Congressional Health Care Plan vs. Catholic Medical Ethics: Part 1- HR 3200

Dear friends in Christ, I have just concluded reading a summary of the Congressional Health Care Plan, HR 3200, presently (2010) before the House of Representatives. What I read turned my stomach. This Bill is not concerned about money or government (miss)management. Stripped of its legalese this Bill is concerned with euthanasia and abortion, "the power to determine who lives and who dies in America."(1)

I believe Rev. Rick Joyner's personal response to HR 3200 is an excellent response. "National Health Scare", his retort to HR 3200, is germane because members of both parties have read and appreciated his writings in the past. He notes: "In Germany, the National Socialists (Nazis) gradually desensitized to death beginning with abortion. Then they quietly, seemingly with the most noble intentions, rounded up the retarded and insane, claiming the state could take much better care of them, but no one ever saw or heard from them again. Then they did the same with the elderly. As word slipped out that they were being euthanized, it was explained that war made it necessary to eliminate all the 'useless eaters' so the troops could be fed, as well as those who worked for the war machine. By that time, the grip of control was too strong for anyone to protest or they would be sent to the camps. Life became cheaper and cheaper, people became more depraved, and millions were slaughtered in the death camps.

"America is following a parallel course. If Hitler had a tool such as the health bill that is being proposed by Congress, along with the technology of control now available, it would have made his task much easier and more effective, and probably resulted in many millions more having been easily murdered".(2)

Our National Health "Care" bill is designed to place the authority to determine who lives and who dies in the hands of another Czar, nothing more than a bureaucrat, who will decide if your parents can receive treatment, even in life and death cases or whether you or your children should receive treatment even if it is a life or death situation.

Please, rise up and take a stand against what is happening today. Attend TEA parties, call, write or e-mail your Congressman and Senators and let them know what you think and where you stand. I've provided addresses, phone numbers, and websites at the end of this article. I have parsed salient parts of HR 3200 below which refer specifically to euthanasia and abortion. Use this information when contacting your Representatives and Senators.
HB 3200

*Pg 425 Lines 4-12: Government mandates Advanced (Death) Care Planning Consultation. Think senior citizens end of life.

*Pg 425 Lines 17-19: Government will instruct and consult regarding Living Wills, Durable Powers of Attorney. *Mandatory!* (It is my understanding a consult occurs every five years after age 65.)

*Pg 425 Lines 22-25: Pg 426 Lines 1-3: Government provides approved list of end of life resources, guiding you in death.

*Pg 427 Lines 15-24: Government mandates program for orders for end of life. The government has a say in how your life ends.

*Pg 427 Lines 1-9: An "advanced care planning consult" will be used frequently as patient's health deteriorates .

*Pg 429 Lines 10-12: "Advanced care consultation" may include an ORDER for end-of-life plans. An order from the government.

*Pg 429 Lines 13-25: The government will specify which doctors can write an end-of-life order.

*Pg 430 Lines 11-15: The government will decide which level of treatment you will have.

*Pg 769 Lines 3-5: Nurse Home Visit Services-concerns "increasing birth intervals between pregnancies"

Government ABORTIONS anyone?

*Pg 770 Sec. 1714: Federal Government mandates eligibility for State Family Planning Services. Abortion and State are Sovereign.

*Pg 838-840: Government will design & implement a Home Visitation Program for families with young children & families expecting children.

*Pg 844-845: This Home Visitation Program includes the Government coming into your home and telling you how to parent!

Those proposing this bill claim two things; 1. The word "euthanasia" is not used in HR 3200; therefore, it should not be inferred; 2. It would only pay doctors "for counseling patients about end-of life care...if the patients wanted it".(3) Further, this bill would not "basically pull the plug on grandma because we decided that its to expensive to let her live anymore..."(4)

Friends, I pray along with Rev. Joyner that every Christian will rise up and take a stand against what is happening in our country. We can stop this if we take a stand. If we do not, what will we say to our God and Judge, Jesus, having this happen on our watch. As a Catholic Christian, I join with Rev Joyner in standing up for the truth regardless of the consequences. The Apostles and martyrs were persecuted and suffered shame rather than deny Our Lord. We can do no less. Read the bill for your selves. I have a 9 page synopsis I would be happy to e-mail to anyone who wants it. My e-mail is noted below, along with the addresses of our Senators and Congressmen. The brief outline and comments contained in this bill were put together by Mr. Mat Staver of the Freedom Foundation and Liberty Counsel. I believe his comments are correct considering this 1000+ page tome is replete with obfuscation. Please don't sit this one out.
